### *Transportation risks:*

MN Risk 500 mile radius \$1mil liability, \$100,000 UM/UIM, Basic PIP, \$75,000 Cargo w/\$1000 deductible, phys damage comp/collision \$1000/\$1000, 3 tractors/4 trailers \$35,469.

MN Risk – metro local radius - NON-handicapped/non-emergency transport \$300,000 liability, \$100,000 UM/UIM, Basic PIP Mini-van \$2612

WI Risk – Milwaukee – Cargo Van 300 mile radius hauling parts, \$500,000 liability, \$500,000 UM/UIM, \$2500 cargo/\$500 deductible, phys damage comp/collision \$500/\$500 = \$2793

GL - Trucker - \$1mil/2mil limits, \$400  
Property - Vacant building \$265,000 TIV, \$710 (3month term)  
E&O - Tax Preparer - \$1mil limits, \$790  
Inland Marine - \$35,000 Logging equipment, \$700  
Non Profit D&O - \$1mil limits with \$1mil EPL, \$900

### *Vacant Dwelling & Excess Personal Umbrella:*

6 Month Vacant Dwelling with renovations, \$1,000,000 CSL, Dwelling Value \$110,000 = \$660  
3 Month Vacant Mobil Home, \$300,000 CSL, Value \$23,000 = \$150  
Annual Vacant Dwelling with Renovations, \$300,000 CSI,  
Dwelling Value \$92,700, Other structures \$9,270 = \$1,223.00  
Excess Personal Umbrella \$2M Excess of \$3M Total Limit \$5M = \$590  
Excess Personal Auto Difference between \$250/500/100 &  
Total Limits of \$500/500/100 = \$436  
Personal Umbrella –Husband & Wife \$1M Limit = \$196
